

How to Set Up a Charitable Impact Account


- Go to www.charitableimpact.com

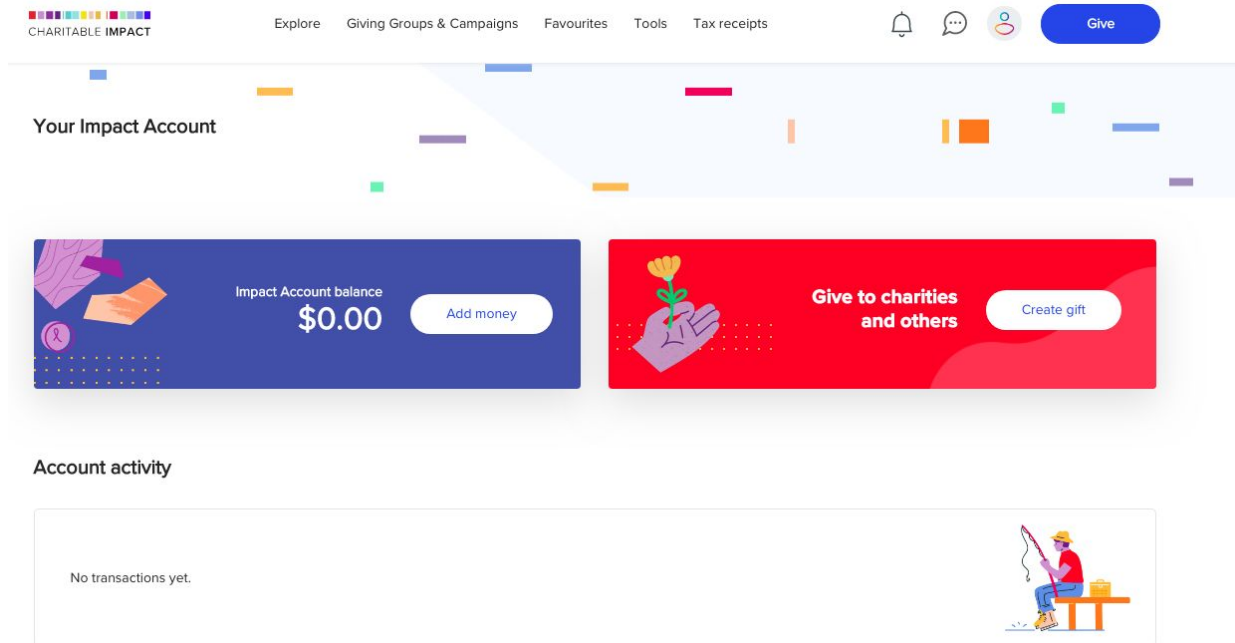
- Once complete you will be sent a welcome email
- Scroll to the bottom and click on Get Started with your Impact Account



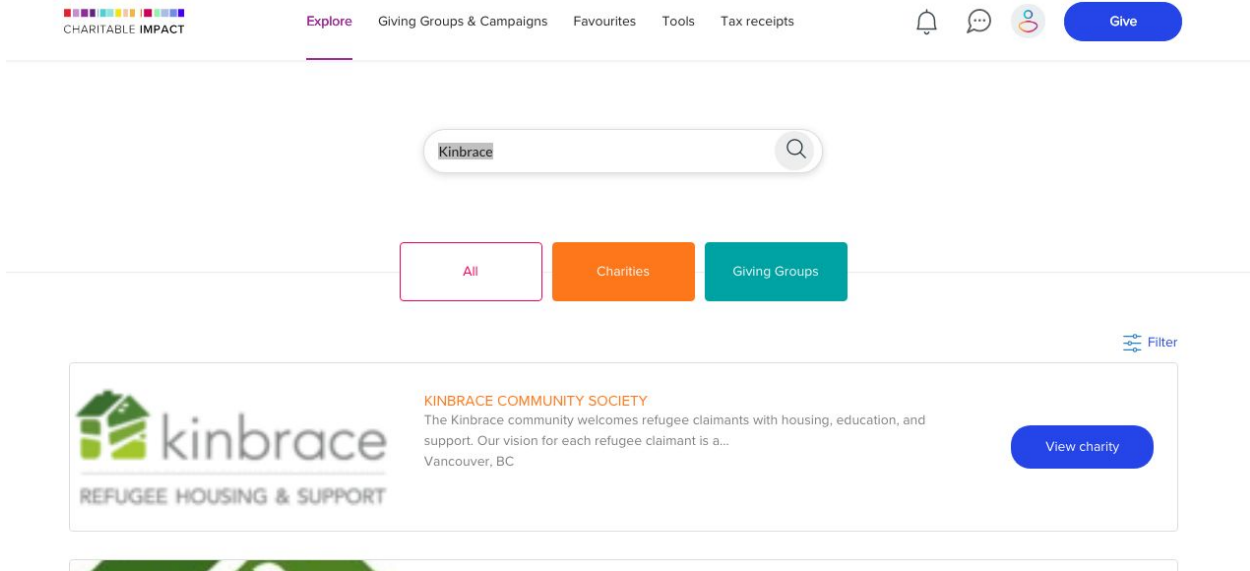
- You will need to log in



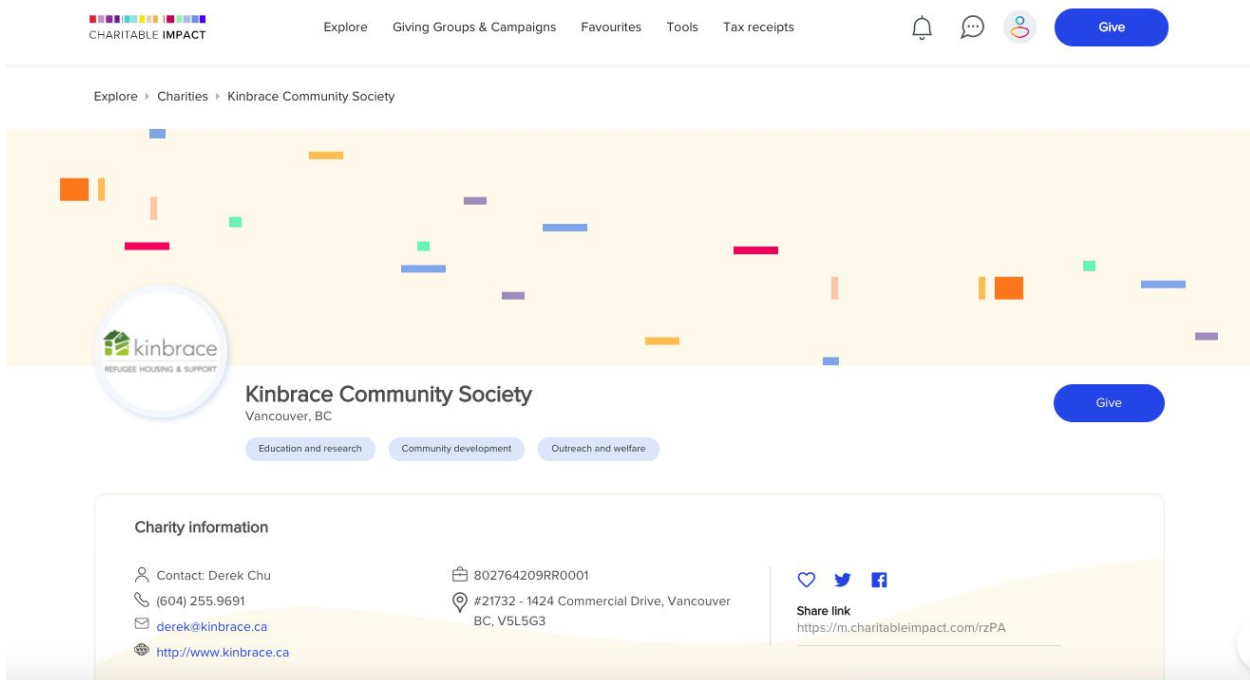
- Click on **Create gift**
